



Terms & Conditions

1. Interpretation

1.1. In these Terms and Conditions ("these conditions"), the following terms shall have the following meanings:

'**Registration Forms**' - Participant Registration Form, Medical Form, Photo Permission Form;

'**Summer Camp**' the camp which the Participant is attending;

'**Participant**' the child or adult who will be attending the Summer Camp;

'**Gorizont Social Enterprise CIC**' – School of Russian Language and Art "Gorizont", 92 Sevenoaks Road, Eastbourne, East Sussex, BN23 7LQ, company number 9672873;

'**Fees**' the fees shown on the School of Russian Language and Art "Gorizont" website or published literature relating to the Services;

'**Full Fee Date**' the date specified in the 'dates & prices' section of the website by which the fees relating to the Summer Camp must be received;

'**Location**' the location of the Summer Camp;

'**Services**' the provision of the Summer Camp for the Participant by the School of Russian Language and Art "Gorizont";

1.2 The headings in these Conditions are for convenience only and shall not affect their interpretation.

2. Supply of Services

2.1. Gorizont Social Enterprise CIC shall provide the Services to the Participant subject to these Conditions. By booking and paying the fees you agree on behalf of yourself and your child/children to be bound by these Conditions. These Conditions constitute the entire agreement between Gorizont Social Enterprise CIC and the Participant and may not be varied except in writing by a Directors of Gorizont Social Enterprise CIC.

2.2. Bookings are accepted at the discretion of Gorizont Social Enterprise CIC and are not transferable.

2.3. You shall fully complete all Registration Forms and at your own expenses supply Gorizont Social Enterprise CIC with all necessary and other information required by Gorizont Social Enterprise CIC in connection with the Services.

2.4. Gorizont Social Enterprise CIC may correct any typographical or other errors or omissions in any Gorizont Social Enterprise CIC material relating to the provision of the Services without incurring any liability to you.

3. Payment of Fees

3.1. You shall pay Gorizont Social Enterprise CIC the Fees and any additional sums which are agreed between you and Gorizont Social Enterprise CIC for the provision of the Services.

3.2. On acceptance of your booking, you have to pay £50 non-refundable registration Deposit. A non-refundable registration Deposit is used per family per shift to hold a participants spot in the Summer Camp. This is a fee charged at the time of registration and is considered part of the whole cost of the Services. When Deposit is received Gorizont Social Enterprise CIC will issue an invoice or Confirmation Letter for the balance of the Fees (the 'Balance').

3.3. The Full Fee Date for the balance of Summer Camp Fees is 24/03/2020. After 24/03/2020, full payment is due at time of registration. If Gorizont Social Enterprise CIC does not receive the

balance by the Full Fee Date, it will have the right to terminate this agreement on written notification to you.

Payment Includes: tent pitch, food, entertainment and activities.

3.4. Where a Registration Form is received by Gorizont Social Enterprise CIC after the Full Fee Date, it must be accompanied by the Full Fees. On acceptance of such as Booking, Gorizont Social Enterprise CIC will issue a confirmation.

4. Cancellation

4.1. If you wish to cancel a Summer Camp booking for any reason, you must do so in writing to Gorizont Social Enterprise CIC. Cancellation may be done via email. Please email school@gorizont.uk. The Summer Camp registration may be canceled before 25/03/2020 thereafter the outstanding fees become due and payable. If the Participant must cancel for medical reasons, a full refund of the balance will be reimbursed on receipt of a doctors certificate.

Gorizont Social Enterprise CIC reserves the right to apply the following cancellation charges:

Non-refundable registration Deposit (£50) – cancellation charge 100%

Cancellation for medical reasons (with appropriate doctors certificate) 0%

4.2. If for any reason, the Summer Camp is canceled by Gorizont Social Enterprise CIC the total liability of Gorizont Social Enterprise CIC will not exceed that proportion of the Fees Gorizont Social Enterprise CIC have actually received.

5. Rules, Regulations and your Liability

5.1. The Participant shall be liable for any liability, financial or otherwise, or injury or damage to property caused by the Participant whilst at the Location, and shall fully indemnify Gorizont Social Enterprise CIC, their agents, contractors and/ or employees for any loss, damage, costs or expenses resulting from such liability, injury or damage.

5.2. Gorizont Social Enterprise CIC reserves the right to make Participant Code of Conduct. The Participant Code of Conduct forms part of these Conditions and will be notified to the Participant at the Location or earlier.

5.3. Any failure by the Participant to adhere to the Participant Code of Conduct may result in his/ her participation at the Summer Camp being terminated forthwith without refund.

5.4. Without prejudice to paragraph 5.3 above, Gorizont Social Enterprise CIC reserves the right to withdraw the Participant from any activity at any time on the grounds of safety or unsuitability.

6. Liability

6.1. Except in respect of death or personal injury caused by Gorizont Social Enterprise CIC negligence, Gorizont Social Enterprise CIC shall not be liable to the Participant by reason of any representation (unless fraudulent) or any implied warranty, conditions or other term or any duty at common law or under the express terms of this Agreement for any loss of profit or any indirect, special or consequential loss, damage, costs, expenses or other claims (whether caused by or negligent or the negligence of our servants, or agents or otherwise) which arise out of or in connection with the provision of the Services or their use by the Participant, and our entire liability under or in connection with this Agreement shall not exceed the amount of our Fees for the provision of the Services.

6.2. Where Gorizont Social Enterprise CIC provides, in connection with the provision of the

Services, any goods or equipment or services supplied by a third party, Gorizont Social Enterprise CIC does not give any warranty, guarantee or other terms as to their quality, fitness for purpose, performance or otherwise.

6.3. Gorizont Social Enterprise CIC shall have no liability to the Participant for any loss, damage, costs, expenses or other claims for compensation arising from any instructions supplied by you which are incomplete, incorrect, inaccurate or illegible, or arising from the Participant's late arrival or non-arrival, or any other fault of the Participant.

6.4. Gorizont Social Enterprise CIC shall not be liable to you or be deemed to be in breach of the contract by reason of any delay in performing, or any failure to perform, any of Gorizont Social Enterprise CIC obligations in relation to the Services, if the delay or failure was due to any cause beyond Gorizont Social Enterprise CIC's reasonable control.

6.5. Gorizont Social Enterprise CIC reserves the right to alter programs, activities, itineraries, excursions, age brackets, premises and personnel as it thinks fit and without notice.

6.7. Gorizont Social Enterprise CIC will not be bound by any statement unless it is in writing and authorised by a Director of Gorizont Social Enterprise CIC.

7. Medical and Behavioral

8.1. Any medical or behavioral problems of the Participant must be notified to Gorizont Social Enterprise CIC in writing on the Medical Form, and in any event prior to the commencement of the Summer Camp. Gorizont Social Enterprise CIC reserve the right not to accept your Booking on the grounds that any such medical or behavioral problems are not conducive to the other Participant's in the Summer Camp.

8.2. In the event that the Participant becomes ill or incapacitated during the Summer Camp, the Participant agree to medical treatment in accordance with the recommendations of a qualified medical practitioner, including the administration of a general anesthetic and to surgical operations in case of emergency.

8.3. If the Participant becomes ill or comes into contact with any contagious or infectious disease during the 21 days prior to the commencement of the Summer Camp, you must immediately notify Gorizont Social Enterprise CIC in writing and provide a medical certificate from the Participant's doctor giving approval to participate in the Summer Camp.

8.4. It is the Participants responsibility to help Gorizont Social Enterprise CIC prevent the spread of infectious diseases.

8.5. It is the Participants responsibility to tell Gorizont Social Enterprise CIC prior to Summer Camp of any issue or condition that may affect their stay at Summer Camp. These include but are not limited to ADHD, SEN, medical, languages, disability, diet, behavioral/ social issues, child's history.

9. Jewellery, Electronics, Valuables and Lost Property

9.1. Gorizont Social Enterprise CIC will not be liable for any item of jewellery, electronics or valuable property brought to the Location by the Participants.

9.2. Gorizont Social Enterprise CIC will not be responsible for any property left at the Location (by the Participant or otherwise), and may dispose of any such property if not claimed and collected by you within seven days of the end of Summer Camp.

10. Publicity

11.1. You acknowledge that Gorizont Social Enterprise CIC may use for publicity and educational purposes photograph or video taken of the Participant at the Location.

11.2. The Participant shall fully complete Photo Permission Form and return to Gorizont Social Enterprise CIC.

12. Smoking, Alcohol and Drugs

12.1. Possession and consumption of alcohol, tobacco or drugs by the Participants at Summer Camp are NOT PERMITTED UNDER ANY CIRCUMSTANCES. Please note that if the participants does not adhere to this condition, he/she will be removed from Camp in accordance with paragraph 5.3 of these Conditions.

13. Child Protection/ Safeguarding

13.1. Gorizont Social Enterprise CIC will contact Local Safeguarding Children's board if we suspect abuse or in an event of a disclosure.

13.2. It is your responsibility to give Gorizont Social Enterprise CIC information (name, address and other contact details) of every person who is a parent and/or carer and/or has parental responsibilities for the child who will be attending the Summer Camp. It is also your responsibility to tell us who the child normally lives with.

14. Force Majeure

14.1. We shall not be liable for any delay in performing or failure to perform any obligation (including to action any alteration or cancellation) due to any case beyond our reasonable control including lock-outs, strikes, shortages of personnel, labour disputes, war, riot, act of God, civil commotion, terrorism, malicious damage, threats to safety, compliance with any law or governmental order, rule, regulation or direction, accident, environmental contamination, pandemic outbreak of disease, breakdown of plant or machinery, fire, flood, storn, difficulty or increased expense in obtaining workmen, materials, goods or raw materials in connection with the performance of this agreement. No refund will be made, except at Gorizont Social Enterprise CIC discretion.

15. General

15.1 If any provision of these Conditions is held by any competent authority to be invalid or unenforceable in whole or in part, the validity of the other provisions of these Conditions and the remainder of the provision in question shall not be affected.

15.2. This agreement is governed by the laws of England and Wales and the parties submit to the exclusive jurisdiction of the England and Wales Courts.
