

Robinsons Summer Camp 2024 Terms and Conditions

1. Interpretation

1.1 In these Terms and Conditions ("these Conditions"), the following terms shall have the following meanings:

"Registration Forms" - Participant Registration Form, Medical Form, Photo Permission Form;

"Robinsons Summer Camp" - the camp which the Participant is attending;

"Participant" - the child or adult who will be attending Robinsons Summer Camp;

"Gorizont Social Enterprise CIC" is the company that organises and runs Robinsons Summer Camp. The company address is 49 Station Road, Polegate, East Sussex, BN26 6EA, company number 09672873;

"Fees" - the fees shown on the Gorizont Social Enterprise CIC website (www.school.gorizont.uk) or published literature relating to the Services;

"Full Fee Date" - the date specified in these Conditions in clause 3.2 by which the Fees relating to the Robinsons Summer Camp must be received by the Gorizont Social Enterprise CIC;

"Location" - the Location of the Robinsons Summer Camp. The Robinsons Summer Camp is located at Streamside, Coombes Road, Coombes, Lancing, West Sussex, BN15 0RP;

"Services" - the provision of the Robinsons Summer Camp for the Participant by the Gorizont Social Enterprise CIC.

1.2 The headings in these Conditions are for convenience only and shall not affect their interpretation.

2. Supply of Services

2.1 Gorizont Social Enterprise CIC shall provide the Services to the Participant subject to these Conditions. By booking and paying the Fees, you agree to be bound by these Conditions on behalf of yourself and your child/children. These Conditions constitute the entire Agreement between Gorizont Social Enterprise CIC and the Participant and may not be varied except in writing by a Director of Gorizont Social Enterprise CIC.

2.2 Bookings are accepted at the discretion of Gorizont Social Enterprise CIC and are not transferable.

2.3 You shall fully complete all Registration Forms and, at your own expense, supply Gorizont Social Enterprise CIC with all necessary and other information required by Gorizont Social Enterprise CIC in connection with the Services.

2.4 Gorizont Social Enterprise CIC may correct any typographical or other errors or omissions in any Gorizont Social Enterprise CIC material relating to the provision of the Services without making any liability to you.

3. Payment of Fees

3.1 You shall pay Gorizont Social Enterprise CIC the Fees and any additional sums agreed upon between you and Gorizont Social Enterprise CIC for the provision of the Services.

3.2 The Full Fee Date for the Balance of Robinsons Summer Camp Fees is **24/05/2024**. **After 24/05/2024**, full payment is due at the time of registration. If Gorizont Social Enterprise CIC does not receive the Balance by the Full Fee Date, it will have the right to terminate this Agreement with written notification to you.

3.3 Payment includes camping, four-time meals, entertainment and activities.

3.4 Where Gorizont Social Enterprise CIC receives a Registration Form after the Full Fee Date, it must be accompanied by the Full Fees. Gorizont Social Enterprise CIC will issue a confirmation upon acceptance of such as Booking.

4. Cancellation

4.1 If you wish to cancel a Robinsons Summer Camp booking for any reason, you must do so in writing to Gorizont Social Enterprise CIC. Cancellation may be done via email. Please email school@gorizont.uk. The Robinsons Summer Camp registration may be cancelled **before 25/05/2024**. After that, the outstanding fees become due and payable. If the Participant must withdraw for medical reasons, a full refund of the Balance will be reimbursed upon receipt of a doctor's certificate.

Gorizont Social Enterprise CIC reserves the right to apply the following cancellation charges:

25/05/2024 – 25/06/2024	50%
After 25/06/2024	100%

Cancellation for medical reasons (with appropriate doctors certificate) 0%

4.2 If, for any reason, the Robinsons Summer Camp is cancelled by Gorizont Social Enterprise CIC, the total liability of Gorizont Social Enterprise CIC will not exceed that proportion of the Fees Gorizont Social Enterprise CIC has actually received.



5. Rules, Regulations and Your Liability

5.1 The Participant shall be liable for any liability, financial or otherwise, or injury or damage to property caused by the Participant whilst at the Location and shall fully indemnify Gorizont Social Enterprise CIC, their agents, contractors and employees for any loss, damage, costs or expenses resulting from such liability, injury or damage.

5.2 Gorizont Social Enterprise CIC reserves the right to make Participant Code of Conduct. The Participant Code of Conduct forms part of these Conditions and will be notified to the Participant at the Location or earlier.

5.3 Any failure by the Participant to adhere to the Participant Code of Conduct may result in their participation at the Robinsons Summer Camp being terminated forthwith without refund.

5.4 Without prejudice to paragraph 5.3 above, Gorizont Social Enterprise CIC reserves the right to withdraw the Participant from any activity on the grounds of safety or unsuitability.

6. Liability

6.1 Except in respect of death or personal injury caused by Gorizont Social Enterprise CIC's negligence, Gorizont Social Enterprise CIC shall not be liable to the Participant by reason of any representation (unless fraudulent), or any implied warranty, conditions or other term or any duty at common law or under the express terms of this Agreement for any loss of profit or any indirect, special or consequential loss, damage, costs, expenses or other claims (whether caused by or negligent or the negligence of our servants, or agents or otherwise) which arise out of or in connection with the provision of the Services or their use by the Participant, and our entire liability under or in connection with this Agreement shall not exceed the amount of our Fees for the provision of the Services.

6.2 Where Gorizont Social Enterprise CIC provides, in connection with the provision of the Services, any goods or equipment or services supplied by a third party, Gorizont Social Enterprise CIC does not give any warranty, guarantee or other terms as to their quality, fitness for purpose, performance or otherwise.

6.3 Gorizont Social Enterprise CIC shall have no liability to the Participant for any loss, damage, costs, expenses or other claims for compensation arising from any instructions supplied by you which are incomplete, incorrect, inaccurate or illegible or arising from the Participant's late arrival or non-arrival, or any other fault of the Participant.

6.4 Gorizont Social Enterprise CIC shall not be liable to you or be deemed to be in breach of the contract by reason of any delay in performing, or any failure to perform, any of Gorizont Social Enterprise CIC's obligations in relation to the Services if the delay or failure was due to any cause beyond Gorizont Social Enterprise CIC's reasonable control.

6.5 Gorizont Social Enterprise CIC reserves the right to alter programs, activities, itineraries, excursions, age brackets, premises and personnel as it thinks fit and without notice.

6.7. Any statement will not bind Gorizont Social Enterprise CIC unless it is in writing and authorised by a Director of Gorizont Social Enterprise CIC.



7. Medical and Behavioral

7.1 Any medical or behavioural problems of the Participant must be notified to Gorizont Social Enterprise CIC in writing on the Medical Form and before the commencement of the Robinsons Summer Camp. Gorizont Social Enterprise CIC reserves the right not to accept your Booking on the grounds that any such medical or behavioural problems are not conducive to the other Participants in the Robinsons Summer Camp.

7.2 If the Participant becomes ill or incapacitated during the Robinsons Summer Camp, the Participant agrees to medical treatment per the recommendations of a qualified medical practitioner, including the administration of a general anaesthetic and to surgical operations in case of emergency.

7.3 If the Participant becomes ill or comes into contact with any contagious or infectious disease during the 21 days before the commencement of the Robinsons Summer Camp, you must immediately notify Gorizont Social Enterprise CIC in writing and provide a medical certificate from the Participant's doctor approving to participate in the Robinsons Summer Camp.

7.4 It is the Participants responsibility to help Gorizont Social Enterprise CIC prevent the spread of infectious diseases.

7.5 It is the Participant's responsibility to tell Gorizont Social Enterprise CIC before the commencement of the Robinsons Summer Camp any issue or condition that may affect their stay at Robinsons Summer Camp. These include but are not limited to ADHD, SEN, medical, language, disability, diet, behavioural/ social issues, and the child's history.

8. Jewellery, Electronics, Valuables and Lost Property

8.1 Gorizont Social Enterprise CIC will not be liable for any item of jewellery, electronics or valuable property brought to the Location by the Participants.

8.2 Gorizont Social Enterprise CIC will not be responsible for any property left at the Location (by the Participant or otherwise) and may dispose of any such property if not claimed and collected by you within seven days of the end of Robinsons Summer Camp.

9. Publicity

9.1 You acknowledge that Gorizont Social Enterprise CIC may use a photograph or video taken of the Participant at the Location for publicity and educational purposes.

9.2. The Participant shall complete the Photo Permission Form and return it to Gorizont Social Enterprise CIC.



10. Smoking, Alcohol and Drugs

10.1 Possession and consumption of alcohol, tobacco or drugs by the Participants at Robinsons Summer Camp are NOT PERMITTED UNDER ANY CIRCUMSTANCES. Please note that if the Participant does not adhere to this condition, he/she will be removed from Robinsons Summer Camp in accordance with paragraph 5.3 of these Conditions.

11. Child Protection/ Safeguarding

11.1 Gorizont Social Enterprise CIC will contact Local Safeguarding Children's Board if we suspect abuse or in the event of disclosure.

11.2 It is your responsibility to give Gorizont Social Enterprise CIC information (name, address and other contact details) of every person who is a parent or carer or has parental responsibilities for the child attending the Robinsons Summer Camp. You are responsible for telling us who the child normally lives with.

12. Force Majeure

12.1 We shall not be liable for any delay in performing or failure to perform any obligation (including to action any alteration or cancellation) due to any cause beyond our reasonable control, including lock-outs, strikes, shortages of personnel, labour disputes, war, riot, the act of God, civil commotion, terrorism, malicious damage, threats to safety, compliance with any law or governmental order, rule, regulation or direction, accident, environmental contamination, a pandemic outbreak of disease, breakdown of plant or machinery, fire, flood, storm, difficulty or increased expense in obtaining workers, materials, goods or raw materials in connection with the performance of this Agreement. No refund will be made except at Gorizont Social Enterprise CIC's discretion.

13. General

13.1 If any provision of these Conditions is held by any competent authority to be invalid or unenforceable in whole or in part, the validity of the other provisions of these Conditions and the remainder of the provision in question shall not be affected.

13.2. The laws of England and Wales govern this Agreement, and the parties submit to the exclusive jurisdiction of the England and Wales Courts.
